

Annual Meeting of Common Shareholders of GMP Capital Inc. held Thursday, May 2, 2019

REPORT OF VOTING RESULTS

The following matters were voted on at the Annual Meeting of Common Shareholders (the Meeting) of GMP Capital Inc. (GMP) held on Thursday, May 2, 2019. Full details of the matters are set out in the Notice of Meeting and Management Information Circular dated March 22, 2019 (the 2019 Circular), which was mailed to shareholders prior to the Meeting and is available at www.gmpcapital.com or on SEDAR at www.sedar.com.

The Board of Directors and management of GMP recommended that shareholders vote: (i) <u>FOR</u> the election as director of each of the nine nominees listed in the 2019 Circular; and (ii) <u>FOR</u> the appointment of Ernst & Young LLP as auditors of GMP.

1. Election of Directors

By a vote conducted by show of hands, each of the nine nominees listed in the 2019 Circular was elected to serve as a director of GMP until the next annual meeting or until his or her successor is elected or appointed, with the outcome of the vote being as follows:
