REPORT OF VOTING RESULTS

The following matters were voted on at the virtual Annual General Meeting of Common Shareholders (the Meeting) of RF Capital Group Inc. (RF Capital or the Company) held on Wednesday, May 4, 2022. Full details of the matters are set out in the Notice of Meeting and Management Information Circular dated March 21, 2022 (the 2022 Circular), which was made available to shareholders prior to the Meeting and can be accessed at www.meetingdocuments.com/TSXT/RCG, on our corporate website www.rfcapgroup.com and on SEDAR at www.sedar.com.

The Board of Directors and management of RF Capital recommended that shareholders vote: (i) <u>FOR</u> the election as director of each of the ten nominees listed in the 2022 Circular; and (ii) <u>FOR</u> the appointment of KPMG LLP as auditors of the Company.
