

**RF CAPITAL REPORTS RECORD AUA OF \$36.8 BILLION; UP \$6 BILLION IN 2021**

**Toronto, January 4, 2022** – RF Capital Group Inc. (the Company) (TSX: RCG) today reported record preliminary month-end assets under administration (AUA) of \$36.8 billion as of December 31, 2021; an increase of \$800 million from November 30, 2021. AUA is a key performance indicator and one of the financial measures used by management, investment advisors and the Company’s shareholders to assess operating performance.
