

Deposit Instructions

Deposit through online banking

You can easily transfer funds from your bank account to your investment account in much the same way as you would pay a bill online. Here are instructions how:

1. Login to your online banking website or app
2. Follow your financial institution's instructions to **Bill Payments** and then **Add New Payee**
3. Set up a new payee by searching for **Fidelity Clearing Canada**
This is Richardson Wealth's custodian who securely protects your wealth
4. You will then be prompted to enter a **payee account**, enter **<Account Number Here>**
Your Richardson Wealth account number has eight characters with no hyphens or spaces. Please use uppercase letters and note the letter O is not used, only zeros.
5. Under **Description** you should create a clear nickname to remember your account for future transfers
6. You're done

Please note: Repeat the steps above if you are sending money to more than one Richardson Wealth account. This service is only available to Canadian dollar accounts.
